

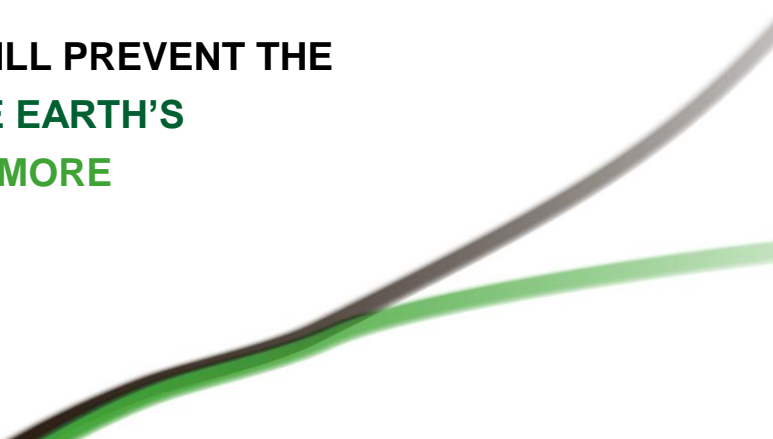

    - **We will look at the INDCs from this perspective!**
  - **To write a new proposal text and introduce it in the negotiation, as a possible key part of the mitigation chapter, towards Paris 2015!**
